Legislative Department Note

It is a well settled principle of law that merely a wrong reference to the power under which certain actions are taken by the Government would not perse vitiate the actions done if they can be justified under some power under which the Government could lawfully do these Acts, Reference in this connection may be made to AIR 1964 S.C. 1329.

In this view of the matter the references already made are legally valid.
