- 9. Filling and Stiching of Bags of Soda Ash/Ammonium Chloride Khad.
- 10. Railway Shuntman/Helper-Services in P. N. F. C.
- 11. Gardening and Supervision of Parks in Factory areas.
- 12. Coal Feeding and Cleaning of Coal belts/Boiler Keri Belts/Boiler Kery Drains.
- 13. Feeding of Sodium Biocarbonate/Ammonium Chloride Khad and Cleaning of Calciner Belt/Dryer Belts.
