THE 7TH JULY, 1991**

No. G. S. R. 38/P.A. 16/56S. 24/Amd. (2) 94—With reference to Government of Punjab, Department of Labour and Employment, Notification No G.S.R. 27/P.A. 16/56/S. 24/And/94, dated the 25th March, 1994, and in exercise of the powers conferred by section 24 of the Punjab Industrial Housing Act, 1956 Punjab (Act No.16 of 1956) and all other powers enabling him in this behalf, the Governor of Punjab is pleased to make the following rules further to amend the Punjab Industrial Housing Rules, 1982, namely.

1. These rules may be called the Punjab Industrial Housing (First Amendment) Rules, 1994.
2. In the Punjab Industrial Housing Rules, 1982, in rule 4, in sub-rule (1), in clause (ii) for the words “One thousand rupees” the words, “Two thousand and five hundred rupees” shall be substituted.
