CERTIFICATE OF COMPETENCY

3. Copies of examination reports shall be sent to the concerned Deputy/Assistant Director of Factories in all cases with a copy to Director of Factories, Govt. of Punjab, Chandigarh.
4. The Director of Factories reserves the right to revoke, annual or amend or cancel his certificate at any time during its validity without assigning any reasons thereof.
5. All the testing facilities at the disposal of competent person shall be maintained in good working order.
6. The Certificate of competency issued in favor of person shall stand cancelled if the person leaves the organization.
7. The report of examination of the above said plants/equipments will be prepared in accordance with the relevant provisions of the Factories Act 1948 and Punjab Factories Rules 1952 and will be signed by the person making the examination/testing and will also be countersigned by the Head of the Institution with rubber stamp affixed thereon, in case the inspection has been carried out by a person so authorized by the Institution and recognized to be a competent person.
