CERTIFICATE OF COMPETENCY

I, Harbhupinder Singh, I.A.S., Director of Factories, Punjab, exercising the powers of Chief Inspector of Factories, Punjab, conferred on me under clause (ca) of Section 2 of the Factories Act, 1948 and the rules made thereunder, hereby recognize Sh. Pardeep Kumar Gupta and Sh. Sarabjeet Singh Makkar of M/s Boss Technical Services Pvt. Ltd, A2/295, Pankha Road, Janak Puri, New Delhi to be competent persons for the purpose of carrying out tests, examinations, inspections and certification of dangerous machinery, lifts and hoists, lifting machines and lifting tackles and pressure plants and equipments as the case may be used in factories located in the State of Punjab under Sections 21 (2), 28, 29 and 31 of the Act ibid and the Rules made thereunder.

This certificate is valid for one year with effect from date of issue. This certificate is subject to the conditions stipulated hereunder:-

1. The tests, examinations and inspections shall be carried out in accordance with the provisions of the Act and the Rules made thereunder.
2. The tests, examinations and inspections shall be carried out under the direct supervision of the competent person.
3. Copies of examination reports shall be sent to the concerned Deputy/Assistant Director of Factories in all cases with a copy to Director of Factories, Govt. of Punjab, Chandigarh.
4. The Director of Factories reserves the right to revoke, annual or amend or cancel his certificate at any time during its validity without assigning any reasons thereof.
5. All the testing facilities at the disposal of competent person shall be maintained in good working order.
6. The Certificate of competency issued in favour of person shall stand cancelled if the person leaves the organization.
7. The report of examination of the above said plants/equipments will be prepared in accordance with the relevant provisions of the Factories Act 1948 and Punjab Factories Rules 1952 and will be signed by the person making the examination/testing and will also be countersigned by the Head of the Institution with rubber stamp affixed thereon, in case the inspection has been carried out by a person so authorized by the Institution and recognized to be a competent person
