In section 3,In sub-section (2),-
  - (I) In clause(e), the word"and" Occurring at the End,shall be omitted: and
  - (II) In clause (f),for sigh", " Occurring at the end,the sign and word ", " Shall be substituted and thereafter, the following clause shall be Inserted, namely:-  
"(g) Contribution of employers and employees."
