





 Open your web browser and go to http://pblabour.gov.in web portal, if applicant is new please refer New User Registration manual otherwise applicant (with provided username and password) has to go to login page either by clicking LOGIN menu at top right corner or Existing User Login button on home page of web portal as shown in screenshot below:
