DRAFT RULES

- **1.(1)**These rules may be called the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) (1stAmendment) Rules, 2023.
- (2) They shall come into force on and with effect from the date of their publication in the Official Gazette.
- **2.**In the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Rules, 1983, for rule 12, the following rule shall be substituted, namely:-
- "12. Fees (1) The fees to be paid for the grant of a certificate of registration of an establishment under section 4 shall be specified below: -

If the number of migrant workmen proposed to be recruited for employment or proposed to be employed in the establishment on any day-

(a)	is 5 but does not exceed 20	200
(b)	exceeds 20 but does not exceed 50	500
(c)	exceeds 50 but does not exceed 100	1000
(d)	exceeds 100 but does not exceed 200	2000
(e)	exceeds 200 but does not exceed 400	4000
(f)	exceeds 400	5000

(2) The fee to be paid for the grant of a license under section 8 shall be as specified below: -

If the number of migrant workmen to be recruited for employment or to be employed by the contractor on any day-
