**No. Labour-LabOPSCA/1/2024-2L/929145** Whereas the General Elections to Legislative Assembly, 2024 for which poll shall be held in neighboring states, as per schedule detailed below as per letter No. Elec-2024/R-8368 dated 04-09-2024 of Chief Electoral Office, Punjab and whereas, it is considered necessary to provide opportunity to those workers who are working in registered shops in the State of Punjab and are enrolled as voter in the State of Haryana and UT of Jammu and Kashmir to exercise their franchise.

Therefore, in exercise of the powers conferred by second proviso to sub-section (1) of Section 10 of the Punjab Shops and Commercial Establishments Act, 1958 (Punjab Act No. 15 of 1958) and all other powers enabling him in this behalf, the Governor of Punjab is pleased to fix Wednesday falling on 18<sup>th</sup> Sept 2024, Wednesday falling on 25<sup>th</sup> Sept 2024 & Tuesday falling on 01<sup>st</sup> Oct, 2024 and Saturday falling on 05<sup>th</sup> Oct, 2024 to be a 'closed day' for the employees who are voters of UT of Jammu and Kashmir and Haryana respectively working in Shops and Commercial Establishments in the State of Punjab. However 18<sup>th</sup> Sept 2024 (Wednesday), 25<sup>th</sup> Sept 2024 (Wednesday), 01 Oct 2024 (Tuesday) & 05<sup>th</sup> Oct, 2024 (Saturday) shall not be a 'closed day' in lieu of weekly off falling between 18<sup>th</sup> Sept 2024 and 24<sup>th</sup> Sept 2024, 25<sup>th</sup> Sept 2024 and 01<sup>st</sup> Oct 2024 & 01<sup>st</sup> Oct, 2024 and 07<sup>th</sup> Oct, 2024.
