No. Labour-Lab0PSCA/1/2024-2L/1060191 Whereas the General Elections of 16 Gram Panchayats namely i) Bhathalan, ii) Bir Bahadurgarh, iii) Deelwal, iv) Farm Bahadurgarh, v) Majri, vi) Peer Colony, vii) Vidya Nagar, viii) Hira Colony, ix) Guru Nanak Nagar, x) Har Gobind Colony, xi) Karheri, xii) Kasba Rurki, xiii) Mehmampur Jattan, xiv) Nawan Mehmampur Jattan, xv) Shamaspur, and xvi) Shekhpur Kamboan of Block Sanour, District Patiala for which poll shall be held in the State, as per Memo No. SEC-PE-SA-2024/1488, Dated 17-03-2025 of State Election Commission, Punjab and whereas, it is considered necessary to provide opportunity to those workers who are working in registered Shops and Establishments in the State of Punjab and are enrolled as voter within the revenue jurisdiction of the 16 Gram Panchayats of Block Sanour, District Patiala, to exercise their franchise.

Now, therefore in exercise the power conferred by sub-section 1 of Section 10 of the Shops and Commercial Establishment Act, 1958 and all other powers enabling him in this behalf, Governor of Punjab is pleased to exempt those workers who are working in the registered Shops and Establishments situated in the State of Punjab and are enrolled as voter within the revenue jurisdiction of the 16 Gram Panchayats of Block Sanour, District Patiala from the operations of provisions of sub-section 1 of Section 10 of the said act on the date of poll 30th March, 2025 (Sunday). However, 30th March, 2025(Sunday) shall not be a 'Closed Day' in lieu of weekly off falling between 24th March 2025 to 30th March, 2025.




