NOTIFICATION

No. Labour-LabOESTB/21/2023-1L/1402-1409 In continuation to the Notification No. Labour-LabOESTB/21/2023-1L/1319 dated 30-10-2023, keeping in view the administrative requirements/reasons the following amendments/corrections are being done with effect from 01.12.2023:-

- 1) The jurisdictional area of tehsil Kalanaur and Dinanagar was left out in Notification dated 30-10-2023, therefore Labour Inspector Gurdaspur will have jurisdiction over the jurisdictional area of tehsil Gurdaspur, Kalanaur and Dinanagar.
- 2) Labour Inspector, Batala-2 will have jurisdiction over entire jurisdictional area of tehsil Batala and Dera baba Nanak excluding the area of Labour Inspector Batala-1.
- 3) The jurisdictional area of tehsil Amloh has already been covered in jurisdiction of Labour Inspector Mandi Gobindgarh-1 and Labour Inspector Mandi Gobindgarh-2. The jurisdictional area of tehsil Khamano will be part of the jurisdiction of Labour Inspector, Fatehgarh Sahigh at Sarhind. Therefore, the Circle Labour Inspector Khamano is hereby abolished.
- 4) The jurisdictional area of tehsil Chamkaur Sahib and Morinda was left out in Notification dated 30-10-2023, therefore Labour Inspector Ropar will have jurisdiction over the jurisdictional area of tehsil Chamkaur Sahib and Morinda.
- 5) The following correction is being done in the jurisdictional area Labour Inspector, Ludhiana-7 and Ludhiana-12:-

Labour Inspector, Ludhiana-7	Area starting from verka chowk on Ludhiana ferozepur road upto start of jagraon tehsil right hand side. Area starting from verka chowk on Sidhwan sirhind canal upto village Khanpur and the end of Ludhiana west tehsil <u>left</u> hand side. Area starting from Khanpur of Ludhiana west tehsil upto Majra via Alamgir, sarinh, Dhandra, Bihla, Narangwal, lohgarh, Phallewal, Jarahan, Ghughran, dharot, chhapaar majra of Ludhiana west tehsil right hand side.

Labour Inspector, Ludhiana-12	<p>Area starting from Basti Jodhewal chowk to Ludhiana rahon road via Meharban Mattewara backside <u>of the left hand side</u> of road upto the end of Ludhiana East tehsil.</p> <p>Area starting from Basti Jodhewal chowk to Delhi-Jalandhar road upto the end of Ludhiana distt right hand side.</p> <p>It includes Shimla colony, new kailash nagar, kailash nagar, janta colony, mangal deep nagar, rajguru nagar, bahadurke road, Nurwala road, kakowala road.</p>

- 6) As jurisdictional area of tehsil Sahnewal is being covered in more than one circle of Labour Inspectors, so to minimize the confusion Labour Inspector Sahnewal is being renamed as Labour Inspector Ludhiana-13.
- 7) It is also clarified that in Jurisdiction of Factory Wing, tehsil Phillaur is not part of jurisdictional area of DDF Jalandhar-2, which mean tehsil Phillaur is part of jurisdictional area of DDF Jalandhar-1.
